Motion:

That John Kenkel be invited to the COCTYC Retreat on Thursday 19 Mar 2009 in Salt Lake City and to pay for one night lodging and one day of meals. Motion seconded, passed via email Feb 11, 2009.

Motion:

That Tom Jose from Blinn College in Bryan, Texas be added to the Southern RAB. Motion seconded, passed via email March 16, 2009.

- I. Meeting called to order by Candice McCloskey at 9:15 am.
- II. Minutes of 183rd COCTYC Meeting at Anne Arundel Conference Nov 22, 2008.

Discussion:

It was noted that the gaps in the minutes from 182nd COCTYC Meeting were not filled in any further.

Motions:

Motion to accept the minutes from the 182nd meeting in Las Vegas as is. Motion seconded and passed unanimously.

Motion to accept the minutes from the 183rd meeting at Anne Arundel Community College. Motion seconded and passed unanimously.

III. Future Sites Report

Dolores distributed copies of the Future Sites Report. (see Appendix)

Discussion:

City College of San Francisco for Spring 2010 appears to be a go. They will be bringing a call for papers to this conference (Salt Lake City).

Potential hosts for the 191st Conference in the Anaheim, CA area will be in attendance here in Salt Lake City to discuss further plans.

The folks at Stark State College will be looking at a meeting in late April or May of 2011 for the 192nd Conference – potential dates will be discussed with the administration. Amy Jo Sanders and Michele Turner will chair the conference. Bill Stein and Darrel Stein will also chair.

It was reminded that RAB members are available to help recruit sites/conference chairs.

Motion:

To give provisional approval of the 187th Conference to be hosted by the City College of San Francisco. The provisional approval allows for placing a call for papers in the newsletter. Approval is provisional pending approval of the letter of commitment, budget, etc. **Motion seconded and passed.**

Motion:

To give provisional approval of the 188th Conference to be hosted by Portland Community College in Portland, OR. The provisional approval allows for placing a call for papers in the newsletter. Approval is provisional pending approval of the letter of commitment, budget, etc. Motion seconded and passed.

IV. 184th Meeting Debriefing

As of this day, 61 have registered for the conference and 42 have paid. Visitors will need to pay for boxed lunches at the meeting. Everything else seemed to go very well. John Kenkel was recognized by Neil Bastian for his assistance in putting together the meeting.

V. Newsletter Report

Jim gave the newsletter report. The deadline for the upcoming newsletter is March 25th. Will need to post for Treasurer/College Sponsors Chair, Newsletter Editor, and Chair Elect 2011 in 2009.

Discussion:

Jim stated that the deadlines often seem to come at inopportune times. It was noted that the newsletter editor has some discretion in setting the newsletter submission deadlines.

VI. Treasurer Report

Kelly distributed copies of the treasurer Report. (see Appendix)

Discussion:

We are still waiting for the \$2000 allotment from DivCHED in2009. It was suggested that perhaps an increase in the allotment may be justified, since it has not been increased for a long period of time. There has been a lot of inflation, we have an additional officer, and we are now moving towards a forth conference a year. The $2YC_3$ has also been supporting the ice cream social at the BCCE in recent years.

Paypal is still holding the funds that have been collected for membership fees through the website. Andy has submitted documentation to Paypal for the funds to be released and stated that release of the funds may be imminent. [The funds have since been released.]

We are still waiting for seed money to be returned from Baton Rouge Community College, as well as any membership dues that were collected for the 180th Conference.

Motion:

That a reimbursement of up to \$150 per person may used to pay for COCTYC retreat expenses at the 184th conference. Motion seconded and passed unanimously.

Discussion:

Kelly expressed concerns of what happens when a member runs out of travel money for the given year. It was noted that the Chair has the discretion to approve current expenditures up to \$500. Larger amounts must be approved by the COCTYC.

It was suggested that COCTYC members consider means of saving money whenever/wherever possible when traveling to conferences, by such thing as sharing car rentals or hotel rooms.

Action Item:

Kelly will get an updated version of the Treasurer's Report to Lance before the end of the 184th conference.

Motion:

To set the maximum travel budget for the Chair at \$3200 beginning in 2010. Motion seconded and passed unanimously.

VII. College Sponsor Report

Kelly gave the College Sponsors Report. There are currently 6 college sponsors for 2010. No report was distributed, as invoices recently went out. A few have already paid using PayPal. A list of College Sponsors is maintained on the $2YC_3$ website.

VIII. Industrial Sponsors Report

John Kenkel gave the Industrial Sponsors report for Michele, as he as at this meeting as a mentor. We are currently 29 industrial sponsors, just short of John's goal of 30 college sponsors when John

started as Industrial Sponsor Chairs. We seem to be in steady-state equilibrium, where the number of industrial sponsors leaving matches the number of those joining.

Discussion:

Jim noted that the industrial sponsors be published in an upcoming newsletter.

Motion:

That John be congratulated for his service on COCTYC as the Industrial Sponsors Chair. Motion seconded and passed unanimously.

IX. Membership Report

Frank gave the Membership Report. Current membership stands at 334. The total membership for 2008 was at 381.

Action Item:

Frank will provide breakdown of who has paid via PayPal, at conferences, and via check for membership renewal.

Action Item:

Michaeleen will contact the RAB chairs for the lists of email addresses that have been collected and give them to Frank. Frank will use the list to make contact for recruiting new members.

Discussion:

It was mentioned that membership renewal for multiple individuals from a single source pursued and perhaps that Andy could put something together on the 2YC₃ website for this purpose.

X. RAB Report

Michaeleen distributed copies of the RAB Report. (see Appendix)

Discussion:

The Midwestern RAB will be hurting after this year if we don't get new members recruited, as several terms will be expiring.

XI. Webmaster Report

Andy gave the Webmaster Report. He noted that the ability to pay membership fees and college sponsorship fees via PayPal was added this past fall. It appears to have been successful with over \$1600 collected via PayPal this far.

Discussion:

Andy would like to know which direction he should be going. Perhaps paying conferences via PayPal? There have been problems with a handful of Program Chairs setting up accounts for their

conferences. Ideas to promote payment via PayPal might be to have a discounted conference rate for paying via PayPal included a \$5 discount.

XII. New Business

Discussion:

There was some discussion of the importance of setting goals, developing strategies or visions, for the various offices. There was also some discussion regarding registration/membership fees for invited speakers, though there was no real resolution.

XIII. Old Business

Discussion:

Plaques. Kelly is waiting for an invoice for Ed Kremer for plaques that have been made so far.

2008 Minutes/Reports compilation. Candice is looking for electronic versions of reports for the Baton Rouge meeting and the Las Vegas meeting.

Kelly brought up that the 2YC3 Brochure needs updating.

Dolores reported that the SOCED (Society Committee on Education) task force will be disbanded as of this next Friday the new guidelines for teachers in the two-year colleges now exist.

Motion:

That Dolores be officially recognized for her service on SOCED. Motion seconded and passed unanimously.

There was break from 12:50 pm - 1:40 pm for lunch.

XIII. Retreat Info

The COCTYC Meeting resumed at 4:38 pm to discuss the retreat activities.

Discussion:

A. Activities of the Retreat

The retreat began at 1:40 pm and continued until 4:38 pm.

Jeff made all of the updates on the computer and projected them on the screen. The By-Laws and Policies and Procedures were updated by consensus. It was agreed we would monitor the changes within "Track Changes" within *Word* to keep track of the changes.

In addition to these changes, Jeff will change the Mission stated in the By-Laws to read the same as shown on the $2YC_3$ website (which were approved at the last retreat at Georgia Perimeter College).

Motion:

To accept the changes in By-Law content through Section G. Revisions subject to formatting by Jeff. Motion seconded and passed unanimously.

To adjourn at 4:48 pm. Motion seconded and passed unanimously.
