- Graduation from a practical nursing program within the past two years OR attached letter from employer showing the equivalent of six months recent full-time work experience as a LPN.
- Copy of my current State Board of Nursing LPN license in good standing with license number and effective dates.
- Successful completion of Chemistry 1020 (Interpretive Chemistry) or equivalent; course taken prior to Spring semester 2003 is too old.
- Successful completion of Biology 2113 (Anatomy and Physiology I) or equivalent; course taken prior to Spring semester 2003 is too old.
- Composite score of 19 or above on the ACT Exam or baccalaureate degree exemption. Official* result of ACT score is attached or on my official* high school transcript which is attached.
- Original Certificate of Attendance at a nursing information session dated within the past 12 months is attached.
- A rubric score of 6.0 or above has been achieved.
- Petitions regarding this application (that have been acted upon and approved by the dean) are attached. **All petitions not approved and signed by a dean will be disregarded.**
